PRIVACY NOTICE

For what purposes will we use your personal data?

The personal data we collect from you will be used by us for the following purposes, which are necessary for the service you are requesting:

- Locating the contact persons for our customers and suppliers.
- Indicating the legal representatives of the customers and suppliers.
- To address campaigns or offers.
- Marketing or advertising.
- Business prospecting.

Additionally, we will use your personal information for the following secondary purposes, **which are not necessary** for the service requested, but which allow us and make it easy for us to offer you a better attention:

- Statistical purposes.
